


Mission

THE DORON PURCHASE PROCEDURE

1. The point of entry requires issuance of a Letter of Intent (LOI)

A prospective client is required to send us a LOI "Letter of Intent". At this stage, we are interested in knowing your intended price and quantity, proposed payment method and choice of port.

- 2. The second step is the issuance of a Full Corporate Offer from Doron Commodities In response to the Letter of Intent issued in stage 1 above, the Company will send you Full Corporate Offer and Proforma Invoice. This is for purposes of outlining and or disclosing further procedures and also indicates some of the fundamental terms of the contract that is to come later.
- 3. ICPO & Proof of Funds / Draft Version of Payment Guarantee
 Send us back signed and stamped FCO, ICPO with full bank details and to avoid
 errors, loss of time and extra operational costs, the Buyer issues a draft version of the
 payment guarantee to the Seller for review. This can be in the form of: draft LC, draft
 DLC, draft SBLC, draft Blockfunds or other.

4. "The Contract"


Upon satisfaction of the proof of fund requirement stated above and approval of payment method, we will issue a draft contract outlining all terms and conditions and delivery schedules. This contract can be further negotiated, it is signed and stamped on all pages and lodged in both Buyer's and Seller's bank.

5. Official Payment Guarantee, POP and PB

Within seven (7) banking days of signing the Contract, the Buyer should issue us the Official Payment Guarantee. In return, upon your request, we will issue you bank-to-bank POP "Proof of Product" and Performance Bond of 2%.

6. Shipping and Delivery

Loading, Shipping and Delivery commences within the agreed number of days. As soon as the loading is completed, you will receive all relevant documents and certificates of Insurance, SGS/CCIC inspection, Bill of Lading among others. These are mailed to your office via DHL.

OUR PRODUCT PORTFOLIO

1. THE SUPPLY OF VARIOUS SUGAR TYPES

One of our leading product lines is in Sugar. We have three main product options in terms of sugar specifications available for supply to your market. They are stated below:

1.10 White-Refined Cane Sugar ICUMSA45.

This is White-Refined Cane Sugar. This has no coloring. It is basically a low moisture product. It has no hardness and this ensures the fluidity of this product line. Basically this is made of well-defined crystals. This type of sugar is fine and possesses exceptional whiteness. This type of sugar is good for pharmacy products, confection where crystals appear, transparent syrup, dry mixture where visual aspects flowing and fast suitability are important.

1.20 Crystal Cane Sugar ICUMSA100-200.


Product polarization is at minimum 99.60 percent. Moisture content is 0.07% maximum. The Ash content is 0.07 percent maximum. Solubility on the other hand stands at 100 percent dry and free-flowing. This is reducing sugar within internationally acceptable limits. Radiation is basically normal without presence of cesium or iodine. The granulation is fine. This is suitable for general use of food industry such as drinks, cookies, confectioneries.

1.23 Raw Sugar ICUMSA600-1200 Equivalent

Polarization stands at 94% to 97%. The moisture content stands at 0.09% maximum. Ash content is also 0.09% maximum. Solubility for this type is at 98.4 to 99.0%. This is also reducing sugar within internationally acceptable limits. Finally radiation is normal without presence of cesium or iodine. In terms of granules, it is fine sugar. The final use of this type of sugar is cooking.

1.24 Demerara

This type is granulated sugar with high content of moisture which presents great molasis covering. it is also used as a special product in domestic use as well as in confection and bakery.



FERTILISER PRODUCTS

1. Ammonium sulfate

other name ammonium sulphate, Diammonium sulfate, Sulfuric acid diammonium salt, CAS NO. 7783-20-2.

It contains nitrogen (N) and sulfate (S) nutrients, can be used on agriculture fertilizers for crop production, food additive, lab use and others. The most common use of it is as a soil fertilizer, it provide the N and S nutrients to the crop, help adjust the PH balance of the alkaline soil.

It can be directly used as chemical fertilizer, and can also be used to manufacture compound fertilizer, potassium sulfate, ammonium chloride, ammonium persulfate, etc.

It also has certain uses in food, textile, leather, medicine and rare earth mining industries. Doron Commodities can supply granular or crystal ammonium sulfate. Ammonium sulfate is mainly used as a fertilizer for agricultural, forestry and vegetable crops. It is suitable for alkaline soil, but it is best used as top dressing. Generally, the application rate per 667 square meters is 15-20 kg. The product is easily soluble in water and has relatively little hygroscopicity, which is convenient for storage and use.

Ammonium sulfate can be used as base fertilizer, top dressing and seed fertilizer. Be careful not to use too much when using as seed fertilizer. No matter in paddy field or dry field, ammonium sulfate should be applied deeply.

It should be noted that ammonium sulfate is a physiological acid fertilizer, and appropriate amount of lime or organic fertilizer should be applied in acid soil or when it is applied several times in a row on the same plot

2. NPK Granular fertilizer

The total amount of nutrients in NPK compound fertilizers is generally relatively high, and there are many types of nutrient elements.

One-time application of NPK compound fertilizers can supply at least two or more main nutrient elements for crops at the same time.

NDFY can add TE like Ca, Mg, S, Zn etc into NPK fertilizer granular.

Uniform structure

For example, ammonium phosphate does not contain any useless side components, and its anions and cations are the main nutrients absorbed by crops. The nutrient distribution of this kind of fertilizer is relatively uniform.

Compared with the powdery or crystalline unit fertilizer after being formed into granules, the structure is compact, the nutrient release is uniform, and the fertilizer effect is stable and long.

Due to the small number of side components, it has little adverse effect on the soil.



FERTILISER PRODUCTS

Good physical properties

NPK Compound fertilizers are generally made into granules, which have low hygroscopicity, are not easy to agglomerate, are convenient for storage and application, and are especially convenient for mechanized fertilization.

Storage and Packaging

Because there are few secondary components in NPK compound fertilizers, the content of active components is generally higher than that of unit fertilizers, so it can save packaging, storage and transportation costs.

For example, every ton of ammonium phosphate stored and transported is approximately equal to the storage and transport of 4 tons of calcium superphosphate and ammonium sulfate.

3. D Compound - Basal Dressing Fertilizer

This ensures accumulation of higher yields with an organically enriched fertilizer. Fundamentally, D Compound is a basal dressing that improves soil health. In the same vein, D-compound also also triggers bio-diversity, water retention.

Composition/Nutrients

10% Nitrate (N), 20% Phosphorus Oxide (P 0), 10% Potassium (K 0), Sulfur (S) + Zinc (Zn)
